## All-American and All-State Team John Wiley Brock Post 6683

Comrades, being a member of a Post that continues to support the community and our Veterans is truly remarkable. The National and Department of Alabama VFW provides a means of recognizing the Posts that excel in these areas; the All-American and All-State Team(s). John Wiley Brock Post 6683, while definitely excelling in our support to the community, has not been recognized for this in recent years. It is our goal to ensure that we earn this recognition this program year. In order to do this, the Post needs volunteers to assist with a few Committees and the Executive Committee's oversight to ensure we maintain 'on glide path' for the prerequisites.

#### The prerequisites for Program Year 2021-22 are:

- 1. The Post Quartermaster MUST BE BONDED NLT September 30, 2021.
- 2. The Post must be inspected by November 15, 2021 and all deficiencies cleared up by 31 December, 2021.
- 3. Post will submit proof of Current IRS form 990 submission to the Department HQs NLT 31 December 2021.
- 4. The Post must submit all Trustee Audit reports on time.
- 5. The Post must participate in the VOD Program (Minimum of one complete Package in the District Judging).
- 6. The Post must participate in the Patriot's Pen Program. (Minimum of one complete package in District Judging).
- 7. The Post must participate in a minimum of one of the three levels of Teacher Recognition Program. (Minimum of one complete package to District).
- 8. The Post must purchase and host one Buddy Poppy event during the year.
- 9. The Post must donate a minimum of \$100.00 to Veterans and Military Support (Do this through a phone call to National or the National Website)
- 10. The Post must donate a minimum of .50 per member to the VFW Dept. VSO Program (do this thru the Department)
- 11. The Post must appoint a Post Service Officer. (Headquarters must be notified of name and contact information By October 31, 2021).
- 12. Post membership must be 100% plus one member by 30 April 2022.
- 13. Post membership must include a minimum of 2 new members for the Year.

#### 

- 14. The Post must submit a minimum of one (1) Community Service Report per quarter beginning with July 2021. Post must show a 10% increase from the previous year
- 15. The Post Commander, Post Quartermaster and a minimum of one Trustee must attend the Department School of Instruction. (Posts with Canteens must also have a minimum of one House Committee Member other than CMDR/QM attend).
- 16. The Post Commander (or in their absence Sr. Vice, Jr. Vice) must attend all District Meetings. Attendance will be verified by Dept Representative.
- 17. Post must have an established and active Post Social media Presence for minimum of 4 months prior to 30 April 2022.
- 18. Posts must have 5 Members/Associates sign up for the VFW Action Corps and at least 1 member respond to all action alerts.
- 19. PARTNERING- Conduct 2 Community events. (ie. Buddy Poppy Drives, Recruiting booths, Veterans Outreach, Memorial or Special Veterans events. Must be in the Community, not at the post. The Public and All Veterans must be invited to attend each event. Submit Photos and byline for one of these events suitable for publishing to Department. Partnering with another Organization for this event will also qualify the event towards All-American.
- 20. Post must also have an active and utilized Post relief fund. All Community Service support to help, aid or assist Veterans in need, should be ran through the Post Relief fund.
- 21. Post must input all required data through the All-American Dashboard.

#### The Post needs Comrades to assist with the following Committees:

- ✓ Community Service: to assist the Post in providing support throughout the Enterprise Community.
- ✓ Buddy Poppy Program: to manage the VFW Buddy Poppy Program for the Post
- ✓ Membership: to actively maintain current membership, as well as establish recruiting opportunities.
- ✓ Grants: to research and apply for OPM (other people's monies) for utilization in support of the Post and local Veterans.
- Recognition Programs: to inform and advertise the Voice of Democracy, Patriot's Pen and Teach of the Year Programs. Also establish the parameters for Scouter and First Responder of the Year Programs.

If you would like to assist with any of these Committees, contact the Jr Vice Commander, Mike Sutterfield.







Veterans are now eligible (was just active duty) for free entrance fees for the National Park Service and the U.S. Fish and Wildlife Service and standard amenity recreation fees for the Bureau of Land Management, Bureau of Reclamation, U.S. Forest Service and U.S. Army Corps of Engineers sites, under the annual Interagency Military Pass.

#### <u>Are you eligible?</u>

For purposes of this program, a Veteran is identified as an individual who has served in the United States Armed Forces, including the National Guard and Reserves, and is able to present one of the following forms of valid (unexpired) identification:

- Department of Defense Identification Card
- Veteran Health Identification Card (VHIC)
- Veteran ID Card
- Veterans designation on a state-issued U.S. driver's license or identification card

Gold Star Families are next of kin of a member of the United States Armed Forces who lost his or her life in a "qualifying situation," such as a war, an international terrorist attack, or a military operation outside of the United States while serving with the United States Armed Forces.

#### How to get your Interagency Pass.

Interagency Passes can be obtained in person while visiting a participating site. Visit <u>Places to</u> Get Interagency Passes for a

searchable list and be sure to contact the site before you go, to make sure they are open and have passes in stock. In addition, Military passes, as well as those for seniors and persons with



permanent disabilities, are available online through the <u>USGS Online Store</u> (there is a \$10 fee to order them online).

There are 14 sites in Alabama where you can get the pass for free. The 2 closest are:

## **Breast Cancer Awareness Month**

October is Breast Cancer Awareness Month and the power of pink is everywhere as we observe Breast Cancer Awareness Month. It helps to increase awareness for the second leading cause of cancer deaths in women. According to a study focused on cancer occurrence at Walter Reed Army Medical Center, military personnel were found to be nearly 40 percent more likely to develop breast cancer than non-military people.

The role of military women has significantly expanded throughout history, most notably with their inclusion in combat assignments. An important consideration of expanded duties is the introduction of additional health risks. Working in these dangerous environments often includes exposure to toxins, which may elevate the risk for developing cancers. Environmental factors may provide a huge clue as to why this number is high, but there is more to the story in order to understand breast cancer risk.

In a panel discussion convened by GE Healthcare, distinguished medical professionals and leaders in patient and Veteran advocacy came together to discuss best practices in breast health and the unique circumstances facing servicewomen and women Veterans. A woman's overall risk for developing breast cancer is a complex mix of factors (lifestyle, family history, genetics, etc.) that are unique for each individual. Ilem. Panelist Joy National Legislative Director of DAV (Disabled American Veterans) and a key thought leader in Veteran's advocacy, described several types of toxic exposures that servicewomen may experience.

These include burn pits that produce airborne toxins from burned plastics, chemical solvents, petroleum, and medical and human waste products: water contamination, depleted pesticides. She uranium, and more. acknowledged that VA is conducting research to learn more about the long-term health consequences of exposure to these hazardous toxins and encourages Veterans to sign up for established health registries to help capture relevant data and information about their military service and potential impact on their long-term health.

Another important risk factor for some women is high breast density, which has been found to be a common risk factor for developing cancer. Women with dense breasts often need secondary screening, such as ultrasound, to obtain a better view of the breast tissue and identify potentially hidden, invasive cancers. When a woman's breast cancer risk is elevated, it is important to take overall risk into consideration and to offer appropriate imaging to help detect any cancer at its earliest stage.

So, during this Breast Cancer Awareness month, your local VFW, along with other service organizations are encouraging our veterans to get their regular required exams/test completed in hopes of early detection and prevention. We want all of our veterans who have gave unselfishly of themselves in protecting our freedom and way of life, to continue to have a healthy lifestyle and reap the benefits of the Land of the Free and home of the brave.

#### Steps to making an ID Card Office Online Appointment. (*No more call waiting.*)



- Scan the QR Code. This will direct you to the ID Card Office Locator & Appointments website.
- 2. Enter Location: Fort Rucker or your specific installation or post/location.
- 3. Scroll down and click 'SEARCH'.
- 4. Scroll down and click 'SELECT' for Fort Rucker or your specific installation or post/location.
- 5. Click 'SCHEDULE AN APPOINTMENT'.
- 6. In drop down menu select a 'MONTH' for desired appointment.
- 7. In drop down menu select a day with 'AVAILABE APPOINTMENTS'. If an 'Available Appointment is not available for the month selected select the following month.
- 8. Once a date with 'AVAILABE APPOINTMENTS' has been selected, scroll down and select 'BOOK THIS APPOINTMENT' for the desired time.
- 9. Enter the require information and select 'SAVE'.
- 10. Your appointment confirmation will then be displayed and an email will be sent to your email address.

#### Get an Early Start to Tax Season

Tax season will be here before you know it. The first step in preparing for tax season is to make sure you have an active myPay account and your mailing address is up-to date. If you do not have a myPay account, now is the perfect time to get started.

#### Use myPay to your advantage

myPay is a user-friendly way to manage your pay account. You can easily manage your account using the web browser on your computer or with a connected device like your smartphone or tablet.

You will able to access your 1099-R tax statement much sooner in myPay than through postal mail. 1099-Rs generally become available in myPay in late December, while paper copies aren't mailed until mid-to-late January. You can also download or print your current year tax statement, as well as prior year 1099Rs (up to four prior years for retirees and up to two prior years for annuitants).

While you're in myPay, you can also easily check to make sure we have your correct mailing address. Make sure you keep your address updated if you travel to warmer weather in January and February. Please don't wait until January, February, or March to check access to your myPay account; check now so you can be prepared for tax season.

#### Log on to myPay: https://myPay.dfas.mil

#### **Getting Started with myPay**

If you're not yet using myPay, it's easy to get started. We have a handy step-by-step, downloadable "Get Started with myPay" guide available at: <u>https://www.dfas.mil/RetiredMilitary/manage/mypay</u>

You can request in initial password on the myPay homepage using the "Forgot or Need a New Password" link. The password will be mailed to the address you have on file with DFAS and you will receive it in about 10 business days.

Once you receive your password in the mail, you can return to the myPay homepage and log in with your social security number and the password you received in the mail to create your myPay profile.







#### (Get an Early Start to Tax Season continued)

If you are new to myPay, there is a link "Read how new accounts are added" in the "New User Section" to find out more about how myPay accounts are created. myPay also offers a video tutorial in the "New User" section that will walk you through the steps to create an account.

#### **Reactivating your myPay account**

We know that some of you only use myPay once a year to get your 1099-R during tax season. Then, when you do try to access your account, you discover that your password is expired, lost or forgotten. If this sounds like something that has happened to you, please update your password now, before the tax season starts. Waiting to update your password might mean longer wait times and potential delays in receiving your tax documents.

If your myPay account is in an inactive status because your password has expired, you can follow the simple steps below to reactivate your account.

Go to https://myPay.dfas.mil in your web browser on a computer or connected device

- 1. Click on the "Forgot or Need a Password?" link and enter your Login ID or Social Security Number.
- 2. Choose to send a temporary password to your email or mailing address of record.
- 3. When you receive the temporary password, go back to myPay and log in to reactivate your account.

#### Check your tax withholding

Now is also a good time to check and adjust your tax withholding

#### Use the IRS Tax Withholding Estimator



The IRS has an online Tax Withholding Estimator to help you determine how much tax you need to have withheld. The calculator helps taxpayers estimate if the right amount is being withheld from their income to cover their tax liability. The estimator uses a simple, six-step question-and-answer format using information like marital or filing status, income, withholding, adjustments, deductions and credits.

#### Why Use the Estimator

The IRS encourages everyone to use the Tax Withholding Estimator to perform a "paycheck checkup." This will help you make sure you have the right amount of tax withheld from your paycheck.

There are several reasons to check your withholding:

- Checking your withholding can help protect against having too little tax withheld and facing an unexpected tax bill or penalty at tax time next year.
- At the same time, you may prefer to have less tax withheld up front, so you receive more in your paychecks and get a smaller refund at tax time.

#### When Should You Use the Estimator

If you changed your withholding for the year, the IRS reminds you to be sure to recheck your withholding at the start of the next year. A mid-year withholding change may have a different full-year impact. So, if you do not file a new Form W-4, your withholding might be higher or lower than you intend.

Also, if you had a major life change, such as marriage, the birth of a child, adoption or bought a home.

If you have additional questions about your withholding, consult your employer or tax advisor.

#### **To Change Your Withholding**

Use your results from the Tax Withholding Estimator to help you complete a new Form W-4, Employee's Withholding Certificate, and submit the completed Form W-4 to your employer as soon as possible. Withholding takes place throughout the year, so it's better to take this step as soon as possible.

Many employers have an automated system for submitting an employee's changes for Form W-4. Please be sure to check with your employer to see if they have this option available.

If you receive pension income, you can use the results from the estimator to complete a Form W-4P (PDF) and give it to your payer.

#### **Complex Tax Situations**

This Tax Withholding Estimator works for most taxpayers. People with more complex tax situations should use the instructions in Publication 505, Tax Withholding and Estimated Tax. This includes taxpayers who owe alternative minimum tax or certain other taxes, and people with long-term capital gains or qualified dividends.

#### **Security**

The Tax Withholding Estimator does not ask you to provide sensitive information such as your name, Social Security number, address or bank account numbers.

The IRS does not save or record the information you enter on the estimator.





#### **TRICARE** Asks Have You Updated DEERS Lately?

When TRICARE tried to reach a group of retirees with critical information recently, more than 6 out of 10 had incorrect information in DEERS. Is your information correct?

#### Why do you need to update your information in DEERS?

Your information must be correct in DEERS so that:

- ✓ You and your family maintain access to your medical benefits
- ✓ Your healthcare team can contact you with critical healthcare and appointment information
- $\checkmark$  TRICARE can reach you with vital authorization, claims, and enrollment information
- ✓ Home delivery prescriptions can be delivered properly

#### When do you need to update DEERS?

Beneficiaries need to update DEERS as soon as possible anytime they move, change contact information, or experience a <u>Qualifying Life Event</u> (QLE).

A beneficiary must update DEERS whenever they experience the following (this list is not all-inclusive):

- ✓ Change in sponsor's status
- ✓ Retiring or separating
- ✓ Activating or deactivating
- ✓ Having a baby or adopting
- $\checkmark$  Moving to a new location for any reason
- ✓ Change in a student's full-time enrollment status
- ✓ Becoming eligible for Medicare
- ✓ Death of sponsor or family member

If a beneficiary is enrolled in any TRICARE plan (e.g., TRICARE Prime, TRICARE Select, TRICARE Reserve Select, TRICARE Retired Reserve or TRICARE Young Adult), remind them to also change their address and other personal information with their regional contractor.
